Mobile County Tax Renewal Vote: Vote Yes for Our Children

On Tuesday, March 22, voters in Mobile County will make the decision on whether to renew a set of property taxes that contribute to our public schools. These taxes bring in more than \$55 million annually for Mobile County public schools. If the funding is renewed it will not create new or raise any existing taxes. Should the funding be discontinued, more than 400 teachers and school employees will be laid off, maintenance and repair contributions will be cut, and the number of students per classroom will increase. In addition, schools will experience a decrease in funding for arts, classroom technology and athletics. Not only will our schools suffer from this cut, but it can also hurt business growth in Mobile. SAWDC to Receive Award from the National Fund for Workforce Solutions

On February 15, 2011, the National Fund for Workforce Solutions announced six sites in the South and Southwest that will receive grants totaling \$1.8 million to support job training and career support in their areas. Each of these sites, including SAWDC, will receive \$300,000 over two years. This grant includes \$150,000 in federal money and \$150,000 in private foundation funding. It will allow SAWDC to support workforce partnerships with the maritime, aerospace, healthcare, and process manufacturing industries.
